On page 26 of both the Series 2017-3 Preliminary Prospectus and the Series 2017-3 Prospectus, the Trust disclosed that, as of February 28, 2017, Delta Air Lines co-branded receivables represented approximately 20% of the co-branded receivables in the Trust Portfolio (as such term is used in the Series 2017-3 Preliminary Prospectus and the Series 2017-3 Prospectus). In fact, as of February 28, 2017, Delta Air Lines co-branded receivables represented approximately 20% of the receivables in the Trust Portfolio.
